#### Colfax County Farm & Livestock Bureau 2025 William (Bill) Sauble Scholarship Application Form

The Colfax County Farm & Livestock Bureau will be awarding two (2) \$750.00 scholarships to Colfax County students in May 2025, one each - to a high school senior and a continuing education college, university, trade or vocational school student.

#### Scholarship Rules & Requirements:

1. The applicant must be a resident of Colfax County. The applicant or their families need not be members of the Colfax County Farm & Livestock Bureau to apply however, preference points will be applied to applicants whose family members belong to the CCF&LB as defined on page 4 of this application.

2. The applicant must be a high school senior, home schooled senior or college freshman, sophomore or junior in good academic standing.

3. The scholarships shall be awarded only once a year.

4. The scholarships shall be applied to any college, university, trade or vocational school.

5. The scholarships will be payable either directly to the college/university or individual at the discretion of the Colfax County Farm & Livestock Bureau for expenses such as tuition, books, fees, or room & board.

6. Applicants may apply more than once, but are eligible to receive the scholarship only twice, i.e., one may receive the scholarship as a high school senior and then again as a college student. Preference will not be given to previous recipients.

7. All applications will be numbered with applicant names and parent's names withheld until after recipients have been selected by the scholarship committee – applications are judged blind.

8. If no **<u>continuing education applications</u>** are received, the CCF&LB may at its discretion, award the continuing education scholarship to the **<u>second place high school applicant</u>**.

9. If no <u>high school applications</u> are received, the CCF&LB may at its discretion, award the high school scholarship to the <u>second place continuing education applicant</u>.

10. All application forms must be typed. Supplements (descriptions of school & community activities and essays) should be typed. Non-legible or incomplete applications will not be accepted.

11. An official transcript of the applicant's school record provided by the high school or college/university must accompany application.

12. All applications will be judged on a 125 -point scale. The scale is as follows:

GPA	15 pts
School Activities, Clubs, and Honors	15 pts
Community Activities and Organizations	15 pts
Essay #1	30 pts
Essay #2	25 pts
Financial need	10 pts
Judge's Discretion	10 pts
Farm Bureau Member	5 pts
